BRIEF PROFILE.

I am a researcher at LSE but also a policymaker and economic policy advisor with over thirty years of experience equally spread between positions in academia/research and public policy. I connect the worlds of practice and research in pedagogy and economic policy, focusing on how to design, negotiate and operationalise policy reforms. My current work focuses on geoeconomics, political economy, public policy and on promoting economic capabilities in governments, international institutions, and businesses and I am looking for more impactful work in these areas.

As a researcher and analyst, I have worked on economic development, political economy, state fragility and geoeconomics. As a practitioner, I have worked on economic policy impact through taking various positions in public leadership and by promoting co-creation of knowledge and institution-building. My teaching has focused on geoeconomics, public organisations, political economy, and development economics.
